"Generative AI in the Clerk's Office: Balancing Innovation with Integrity"

- Chris Pahl, Chief Privacy Officer, County of Santa Clara

As generative AI tools become more accessible, Clerks of the Board face a pivotal moment: how to responsibly integrate these technologies into public service without compromising transparency, accuracy, or trust. This interactive session will explore the practical benefits, ethical risks, and policy considerations of using generative AI in clerk workflows, from agenda preparation and public comment summarization to records management and constituent communication.

Participants will also be broken out into small groups to (1) share current or anticipated uses of generative AI in their offices; (2) identify specific challenges or ethical concerns; and (3) co-develop a list of "responsible uses" practices tailored to the clerk's role. Each group will report back with insights and recommendations, which will be compiled into a shared resource for all attendees.

"Questions & Answers on the ADA Title II Web & Mobile App Accessibility Rule"
